Creating a tracker for social, emotional needs is very challenging. It's important to have this tracker to work with students to get them from a 0 to a 1, how to get 1 to a 2. The tracker also helps us coach the advocates as we see their notes. If we see a student that was a 4 but went to a 2, we need to look into this and have the conversation with the student. The graduation celebration will be a parade. It reflects KCA well as we will be going to our students' homes. They will receive their gift basket with alumni sweatshirts and restaurant gift cards so they can celebrate with their families. Board members are welcome to record a 20-second video so we can include it in the graduation parade video to be posted on Facebook.

Progress Report (Mandy Acker): Learning Team has a tracker similar to the Care Team tracker and is being used to monitor student progress. Update on chromebooks. Ordered chromebooks for each student and hot spots. Took some time to set up filters, blockers and getting them ready for student use. Created special forces and put together a plan for the distribution. Monday of this week we have started distributing chromebooks. 23 students have the new chromebooks. Luke: I was really impressed by how well KCA staff is taking care of their students. You can tell that this is not just a job, but a mission.


